### TRAD PRODUCTS USER LICENSE AGREEMENT

#### REDISTRIBUTION NOT PERMITTED

Software License for certain TRAD Products

#### IMPORTANT -- READ CAREFULLY BEFORE USING THIS SOFTWARE:

This License Agreement for certain TRAD Products ("License Agreement") is an agreement between you (either an individual or an entity), the Licensee and TRAD. By clicking on the "Accept" button, installing, copying or otherwise using the software, you agree to be bound by the terms of this License Agreement.

IF YOU DO NOT AGREE TO THE TERMS OF THIS LICENSE AGREEMENT, CLICK ON THE "CANCEL" BUTTON AND/OR DO NOT INSTALL THE SOFTWARE.

YOU AGREE THAT YOUR USE OF THE SOFTWARE ACKNOWLEDGES THAT YOU HAVE READ THIS LICENSE, UNDERSTAND IT, AND AGREE TO BE BOUND BY ITS TERMS AND CONDITIONS.

#### 1. GRANT OF LICENSE.

TRAD hereby grants to the Licensee a non-exclusive license to use the Software, associated programs and any related documentation. This license is delivered on a USB key fob (Dongle). The Software is first installed on a PC and it is initialised by plugging in the Dongle.

The use of this Dongle license is subject to the following terms:

## Tthe Licensee may:

- (i) use the Software on any stand-alone computer (with a single PCU)
- (ii) use the Software on a single geographical location;

# The Licensee may **not**:

- (i) use the Software on a server or network;
- (ii) copy the Software for backup and archival purposes;

### 2. OWNERSHIP OF SOFTWARE.

The Licensee own the Dongle (USB Time key) on which the Software license is originally or subsequently recorded or fixed pursuant to this license purchase, but TRAD retains title and ownership of the Software downloaded via its dedicated ftp server, as well as all subsequent copies of the Software, regardless of the form or media in or on which the original and other copies may exist. This License is not a sale of the original Software or any copy thereof.

#### 3. LICENSE RESTRICTIONS.

The Licensee may install the Software on any single-user computer provided that each computer on which the Software is installed is owned or leased by the Licensee and used exclusively by the Licensee.

The Software is licensed only to the Licensee and may not be transferred, assigned, rented, leased, sold or otherwise dispose of the Software on a temporary or permanent basis except as expressly provided herein.

The Licensee may not distribute any copy of the Software to anyone else. The Licensee may not modify, adapt, translate, decompile, disassemble, reverse engineer, or create derivative works based on the Software. The Licensee may not translate, adapt, modify, or create derivative works based on written materials delivered with or as part of the Software.

The Licensee agrees that he shall only use the software and documentation in a manner that complies with all applicable laws in the jurisdictions in which the Licensee uses the software and documentation, including, but not limited to, applicable restrictions concerning copyright and other intellectual property rights.

The Licensee agrees that the Software will not be used directly or indirectly in any one or more of the following areas:

#### 4. UPDATE POLICY.

TRAD will make available the updated versions of the Software to the Licensee during the first year of the Licenses' purchase. For each year thereafter, the updated versions of the Software will be made available to the Licensee upon purchase of the Maintenance & Support contract for the period specified in this contract.

#### 5. BETA RELEASE VERSIONS.

In the event that the Software is a beta release version, the terms of this section shall apply. Your license to use the Software expires 120 days after installation (or such other period as indicated by TRAD) and the Software may cease to function. The Software you are receiving may contain more or less features than the commercial release of the TRAD Product that TRAD intends to distribute.

While TRAD intends to distribute a commercial release of the software, TRAD reserves the right at any time not to release a commercial release of the Software or, if released, to alter features, specifications, capabilities, functions, licensing terms, release dates, general availability or other characteristics of the commercial release.

You agree that the Beta Release Versions are not suitable for production use and may contain errors affecting their proper operation. You agree that you will not do anything to circumvent or defeat the features designed to stop the Software from operating after the license expires.

### 6. WARRANTIES AND LIABILITIES.

(a) LIMITED WARRANTY.

TRAD warrants that for a period of one (1) year from the date of reception, the Software, if operated as directed, will substantially achieve the functionality described in the Documentation. TRAD does not warrant however that your use of the Software will be uninterrupted or that the operation of the Software will be error-free or secure.

(b) For the Basic, Trial, and Beta versions of TRAD Products, the following terms apply:

### 7. LIMITATIONS OF LIABILITIES.

#### 8. AUDIT.

TRAD may, at any time, either request a signed certification by the Licensee verifying that the Software is being used in accordance with the terms of this License Agreement and/or audit your use of the Software to ensure compliance with the terms and conditions of this License Agreement.
